PART 3: GENERAL TERMS AND CONDITIONS

1. Confidentiality

- 1.1 Each party shall take all reasonable action and shall take at least the same precautions as it takes to prevent the disclosure of its own confidential information, to prevent the disclosure to third parties of the Confidential Information. Each party shall only have the right to disclose the Confidential Information to its officers, directors, employees, agents and consultants for the purposes authorized herein.
- 1.2 Each party shall, prior to disclosing the Confidential Information or portion thereof to any such person, issue appropriate instructions to them to ensure that such persons are aware of their obligation to comply with the confidentiality and use obligations and restrictions contained in this Registration. If each party has taken all such reasonable steps it shall not be responsible if such Confidential Information or any part thereof should be divulged to any third party by reason of honest mistake or dishonest appropriation by any of each party's agents or employees.

2. General Disputes

- 2.1 In the event of any disputes, World FoodChain will facilitate the attempt to resolve any matters between the Buyer and the Supplier, and all to agree to communicate through the use of mutual discussions within reasonable commercial efforts.
- 2.2 If the matters cannot be resolved by mutual discussions, either party may approach the claims tribunal of their local jurisdiction to resolve any dispute arising from a transaction.
- 2.3 All transactions are subjected to the World FoodChain global online/offline commission & processing fee, ranging from 8% to 15% of the total transaction value per purchase order.

3. Governing Law

- 3.1 This Registration shall be governed by and construed in accordance with the laws of the Republic of Singapore without regard to its conflict of law rules. The United Nations Convention on Contracts for the International Sale of Goods and the Uniform Computer Information Transaction Act, to the extent applicable, are expressly disclaimed.
- 3.2 Unless otherwise required by applicable laws, any dispute, controversy, claim or difference of any kind whatsoever shall arising out of or relating to this Registration against or relating to World FoodChain or any Indemnified Party under this Registration shall be referred to and finally resolved by arbitration in Singapore in accordance with the Arbitration Rules of the Singapore International Arbitration Centre ("SIAC Rules") for the time being in force, which rules are deemed to be incorporated by reference in this Section. There will be one (1) arbitrator and the language of the arbitration shall be English.
